# Mali

#### Introduction

1. The United Nations Security Council's sanctions list has been updated.

## Notice summary (Full details are provided in the Annex to this Notice)

- 2. By virtue of the United Nations and European Union Financial Sanctions (Linking) Regulations 2017, the following entries have been <u>added</u> to the consolidated list and are now subject to an asset freeze.
  - Ahmed AG ALBACHAR (Group ID: 13799)
  - Houka Houka AG ALHOUSSEINI (Group ID: 13800)
  - Mahri Sidi Amar BEN DAHA (Group ID: 13801)
  - Mohamed Ben Ahmed MAHRI (Group ID: 13802)
  - Mohamed Ould MATALY (Group ID: 13803)

# Legislative details

- 3. On 19 December 2019, the United Nations Security Council Committee established by Resolutions 2374 (2017) and 2432 (2018) concerning Mali approved the addition of 5 entries to its list of individuals and entities subject to an asset freeze. They were previously subject to a travel ban and continue to be so.
- 4. Unless the DP is listed under EU Regulation 2017/1770 by 18 January 2020. the asset freeze will cease to apply from 11:59 p.m. on 18 January 2020 until the date upon which the DP is listed by the EU.

# What you must do

- 5. You must:
  - i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
  - ii. freeze such accounts, and other funds or economic resources;
  - iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor;
  - iv. report any findings to the FRA at <u>financialsanctions@gov.ky</u>, together with any additional information that would facilitate compliance with the Regulation;
  - v. provide any information concerning the frozen assets of designated persons to the FRA at <a href="maintainsanctions@gov.ky">financialsanctions@gov.ky</a> by completing and submitting a TF/PF Asset Freeze Report Form. Information reported to FRA may be passed on to other regulatory authorities or law enforcement.
- 6. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.
