# North Korea (Democratic People's Republic of Korea)

#### Introduction

1. Council Regulation (EU) 2017/1509 ("the Regulation") imposing financial sanctions in relation to North Korea (The Democratic People's Republic of Korea) has been amended.

# Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entries have been <u>amended</u> and are still subject to an asset freeze:
  - MUNITIONS INDUSTRY DEPARTMENT (Group ID: 12447)
  - RI HONG-SOP (Group ID: 10917)

## What you must do

- 3. You must:
  - i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;

- ii. freeze such accounts, and other funds or economic resources;
- iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor;
- iv. report any findings to the FRA at <a href="mailto:financialreportingauthority@gov.ky">financialreportingauthority@gov.ky</a>, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons to the FRA at <a href="maintailreportingauthority@gov.ky">financialreportingauthority@gov.ky</a> by completing and submitting a TF/PF Asset Freeze Report Form. Information reported to FRA may be passed on to other regulatory authorities or law enforcement.
- 4. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, they are not required to report these details again.
- 5. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

## Legislative details

- 6. On 18 July 2018 Council Implementing Regulation (EU) No 2018/1009 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 181, 18.7.2018, p.1) by the Council of the European Union.
- 7. The Amending Regulation amended Annex XIII to the Regulation with effect from 18 July 2018.
- 8. The Amending Regulation reflects the decisions made on 9 July 2018 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1718 (2006) to amend the identifying information of 2 existing entries subject to restrictive measures.
